Riverton Village Board

The President and the Board of Trustees of the Village of Riverton held their regular board meeting on February 2, 2026, at the Riverton Village Hall, Riverton, IL.

The board meeting was called to order at 7:00 pm. Those answering roll call: Trustees, Johnathan Chisam, Dave Charles, Paul Baker, Joshua Zirkelbach, Jim Mileham, Michelle Landess, and Mayor Joe Bartley.
