Trustee Bartley made a motion to approve Ord #19-007 approving the Ordinance establishing Hotel/Motel Tax in the Village of Riverton II. Landess seconded the motion. Trustee Patrick, Charles, Payne Bartley, Mileham, Landess voted yes.

Trustee Bartley made a motion to approve Ord #19-008 An Ordinance fixing a time and place for a public hearing with respect to a redevelopment plan pursuant to a tax increment allocation redevelopment act, convening a joint review board, and authorizing notice in connection therewith. Payne seconded the motion. Trustee Patrick, Charles, Payne, Bartley, Mileham, Landess voted yes.

Trustee Patrick made a motion to approve Ord#19-009 An Ordinance waiving bids and accepting quotes from JK Snyder Co, Inc for boring of electrical and gas under I-72 in the amount of 40,000. Mileham seconded the motion. Trustee Patrick, Charles, Payne, Bartley, Mileham, Landess voted yes.

Trustee Landess made a motion to approve Res#19-003 A Resolution appointing a representative to the joint review board for the Village of Riverton, IL I-72 Exit 108 TIF District. Mileham seconded the motion. Trustee Patrick, Charles, Payne, Bartley, Mileham, Landess voted yes.

Trustee Payne made a motion to approve Ord#19-010 An Ordinance authorizing execution of agreement number JN 619-004 with the State of IL Dept. of Transportation for the designation of portions of I-55 alternate route and I-72 alternate route within the Village of riverton for emergency passage. Landess seconded the motion. Trustee Patrick, Charles, Payne, Bartley, Mileham, Landess voted yes.

Superintendent Lyons presented the board with his report. (See attached report.) He asked for \$25,000 for gas pipe. Trustee Patrick made a motion to approve that and Mileham seconded. Trustee Patrick, Charles, Payne Bartley, Mileham, Landess voted yes.
